Overview

EDX Markets FIX specifications are based on the FIX Trading Community FIX 5.0 SP2 specifications.

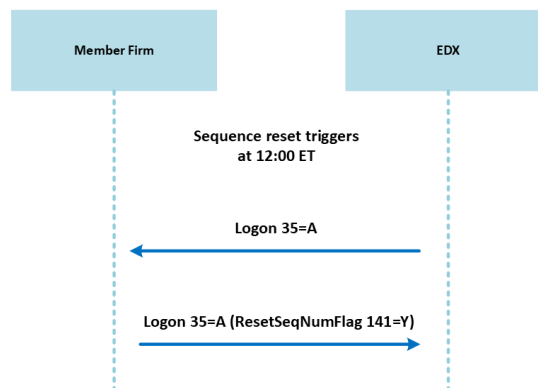
Throttle Limits

- Throttle limits are applied at the FIX ID level (username) and are administered by EDXM Global Market Operations.
 - Maximum messages per username: 100 messages per 5 seconds.
 - In the event you exceed throttle limits, you will receive the message RATE_LIMIT_EXCEEDED and be disconnected.
-

- There is no message throttle mechanism.
- After a disconnect due to rate limit, you can reconnect immediately.

Sequence Reset

- A daily reset occurs at 12pm ET. We follow the FIX protocol convention for resetting sequence numbers back to 1.



Test Request

If your system fails to heartbeat with us in the interval initially declared in the logon message, EDX will issue a Test Request. When that happens, you must respond to that test request within the initially declared heartbeat interval with either a business message or a heartbeat.

Session Recovery

Fills that occur while a FIX session is disconnected will be replay-able from buffer when the session reconnects using a TradeCaptureReport Request with the relevant value in the TrdMatchID Tag.

Supported Messages

The following convention is used in this document to indicate message direction:

- IN: a message type received by EDX.
- OUT: a message type originating from EDX.
- IN/OUT: a message type that can be sent to or from EDX.

The values under the “Required” column indicate one of the following:

- 'Y' – field is mandatory and must be sent or received as a part of the message.
- 'N' – field is not required and should be omitted unless otherwise directed by EDX.
- 'N/A' – Field is not used in the context of the message.

Note - (*) asterisk indicates that provided fields/tags are only applicable for SPOT.

Drop Copy Configuration

The Drop Copy Feed returns Execution Reports. By default, Drop Copy sessions are configured to receive only fill Execution Reports.

Risk Management - Liquidation and Auto-Deleveraging (ADL) Handling

1. Liquidation Threshold Breach

When the ADL threshold is breached, the system will automatically cancel all open orders to manage risk. Clients should be prepared to handle the following:

- Tag 58 (Text):
 - Value: LIQUIDATION
 - Description: This tag will be included in the Order Entry and Drop Copy execution report or order cancellation message to indicate that the action was triggered by a LIQUIDATION event.
 - Action: Clients should process this tag in Order Entry and Drop Copy messages to identify orders canceled due to LIQUIDATION and update their systems accordingly.

2. Drop Copy Execution Report for Filled Trades During Liquidation

During a LIQUIDATION event, the system may generate a drop copy execution report for trades filled by the SYSTEM. Clients should be prepared to handle the following:

- Tag 828 (TrdType):
 - Value: 9000
 - Description: This tag will only be included in the Drop Copy execution report to indicate that the trade was executed as part of a liquidation event.
 - Action: Clients should process this tag in Drop Copy messages to identify trades executed during liquidation and update their systems accordingly.

3. Auto-Deleveraging (ADL) Threshold Breach

When the ADL threshold is breached, the system will automatically cancel all open orders to manage risk. Clients should be prepared to handle the following:

- Tag 58 (Text):
 - o Value: AUTO_DELEVERAGING
 - o Description: This tag will be included in the Order Entry and Drop Copy execution report or order cancellation message to indicate that the action was triggered by an ADL event.
 - o Action: Clients should process this tag in Order Entry and Drop Copy messages to identify orders canceled due to ADL and update their systems accordingly.

4. Drop Copy Execution Report for Filled Trades During ADL

During an ADL event, the system may generate a drop copy execution report for trades filled by the SYSTEM. Clients should be prepared to handle the following:

- Tag 828 (TrdType):
 - o Value: 9001
 - o Description: This tag indicates that the trade was executed as part of an ADL event. It will only appear in Drop Copy messages.
 - o Action: Clients should process this tag in Drop Copy messages to identify trades executed during ADL and update their risk management systems accordingly.

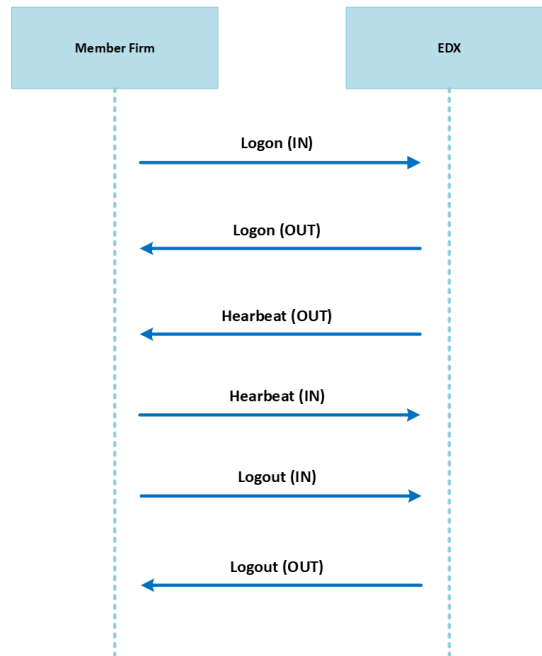

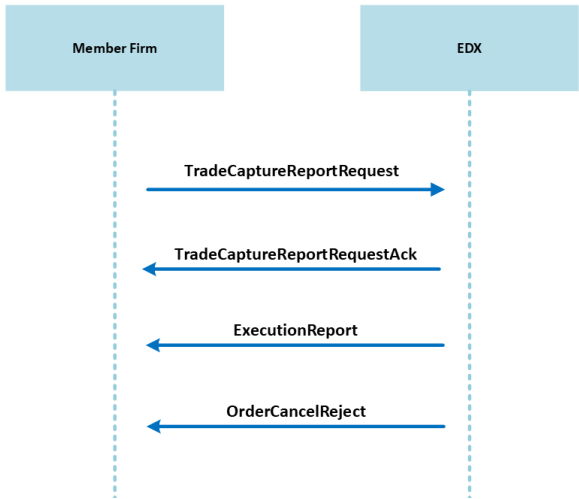
